ASSIGNMENT

WHEREAS, I, **Steven S. Ogg**, a citizen of the United States, residing at 979 Turnstone Road, Carlsbad, California 92009, (hereinafter referred to as "ASSIGNOR"), have invented and own a certain invention entitled "**AERODYNAMIC PATTERN FOR A TWO-PIECE GOLF BALL**", for which application for Letters Patent of the United States of America has been executed on even date herewith;
