We agree that we will at all times keep said assignee advised of our whereabouts; and we will promptly, upon request of said assignee, and without further compensation, but at no out-of-pocket expense to ourselves, do all lawful acts, including the execution of all necessary documents and the giving of testimony that, in the opinion of said assignee, its successors and assigns, may be necessary or desirable for obtaining sustaining, or reissuing United States and foreign Letters Patents relating to the foregoing assigned rights, and for perfecting, affirming, recording, and maintaining the title of said assignee, its successors and assigns thereto; and that we will generally cooperate to the fullest extent in all matters pertaining to said invention and patents and said assignee's title thereto.

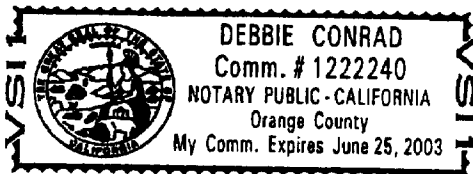

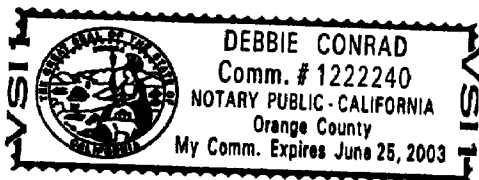
