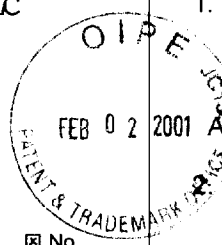

THIS ASSIGNMENT is made the 23rd day of January, 2001.

BETWEEN:

- (1) Conopco, Inc., a New York corporation, Unilever, N.V., a Netherlands corporation, and Unilever, PLC, a Great Britain corporation, with a place of business at 390 Park Avenue, New York 10022 (collectively "Assignor"); and
- (2) DF Enterprises, Inc. a Delaware corporation and affiliate of French Fragrances, Inc., with a place of business at 300 Delaware Avenue, Wilmington, Delaware 19801 ("Assignee").

WHEREAS:

- (A) The Assignee wishes the Assignor to assign any interest it may have in the patents and patent applications (the "Patent Applications") details of which are set out in the Schedule attached hereto (collectively, the "Patents") to the Assignee.
- (B) The Assignor has agreed to assign any interest it may have in the Patents to the Assignee.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. ASSIGNMENT

Pursuant to the Purchase Agreement dated October 30, 2000 by and between Conopco, Inc. and French Fragrances, Inc., as amended (the "Purchase Agreement"), the Assignor hereby assigns to the Assignee for the consideration of \$1.00, the legal sufficiency of which is hereby acknowledged, all its right, title and interest in, to and under the Patents, including all rights, privileges and advantages attaching thereto, including, without limitation, the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements thereof, to hold unto the Assignee absolutely for the full term of the Patents and to the intent that the Assignee shall be absolutely entitled to any patent granted on the Patent Applications for the full term of such patents. Assignee hereby assumes and releases Assignor from any and all obligations related to the Patents and Patent Applications.


2. FURTHER ASSURANCE




