ASSIGNMENT

WHEREAS, we, **Shinji Matsuura**, of Japan; and, **Hajime Morino**, of Japan, have invented certain new and useful improvements in a

PAPER SHEET PROCESSOR AND METHOD OF PROCESSING PAPER SHEET for which an application for U.S. Letters Patent Serial No. 09/688,952 was filed on October 16, 2000.
