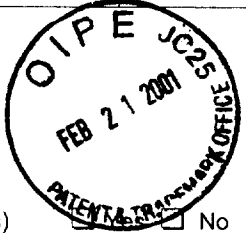


and the application for United States Letters Patent therefor executed by us on and such patents as may issue thereon, and all divisions, reissues and continuations thereof.
