ASSIGNMENT

WHEREAS, Butrus T. Khuri-Yakub of Palo Alto, Santa Clara County, California; F. Levent Degertekin of Millbrae, San Mateo County, California; Sam Calmes of Mountain View, Santa Clara County; and Xuecheng Jin of Stanford, Santa Clara County, all of California, hereinafter termed "Inventors," have invented new and useful improvements in a *An Array of Capacitive Micromachined Ultrasonic Transducer Elements with Through Wafer Via Connections* and have executed application for a U.S. Patent Serial No. 09/667,203 filed September 21, 2000, and

of all petitions, oaths, specifications, declarations or other papers (prepared at the expense of Assignee) which are deemed necessary or desirable by Assignee for prosecuting said application specifically identified herein, for filing and prosecuting substitute, divisional, continuing or additional applications in the United States and/or foreign countries covering said invention and/or improvements, for filing and prosecuting applications for reissuance of Letters Patent included herein, or for interferences (i.e. priority) proceedings involving said invention and/or improvements; and (c) prompt assistance and cooperation in the prosecution of legal proceedings involving said invention and/or improvements, said applications and patents granted thereon, including oppositions, cancellation proceedings, priority contests, public use proceedings and court actions; provided, however, that the expense which may be incurred by said inventors in lending such assistance and cooperation be paid by Assignee.

3. The terms, covenants and conditions of this assignment shall inure to the benefit of said Assignee, its successors, assigns, and/or other legal representatives, and shall be binding upon said Inventors, their respective heirs, legal representatives and assigns.


