

ASSIGNMENT AND AGREEMENT



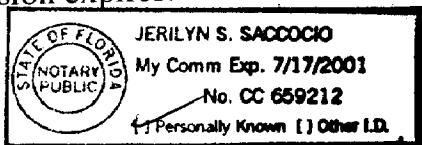


