

ASSIGNMENT

The undersigned Queen's University at Kingston, a non-profit educational corporation, whose full post office address is Kingston, Ontario, K7L 3N6, Canada, (hereinafter **Queen's**), in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby sell and assign to **Randy E. ELLIS**, (hereinafter **Ellis**) whose full post office address is 164 Nelson Street, Kingston, Ontario, K7L 3X1, Canada, all Queen's rights, title and interest, including priority rights, in and to the invention relating to **Method and Apparatus for Evaluating CT Image Registration**, as set forth in the application for Letters Patent of the United States of America, Serial Number 08/610,938 filed March 5, 1996, and issued June 3, 1997 as U.S. Patent No. 5,636,255, and in the application for Letters Patent of Canada, Serial Number 2,201,425, filed April 1, 1997, in and for the United States of America, Canada, and all countries foreign thereto.

The undersigned hereby covenants and agrees that Queen's will execute or procure any further necessary documents of the title to said invention and Letters Patent; and that Queen's will, at any time, upon the request and at the expense of Ellis, execute and deliver any and all papers that may be necessary or desirable to perfect the title to said invention, or any Letters Patent which may be granted therefor, to Ellis; Queen's will, at any time, upon the request and at the expense of Ellis, sign all lawful papers, execute any additional, divisional, substituting, continuing or reissue applications for patents for said invention, or any part or parts thereof; and Queen's will make all rightful oaths and generally do all lawful acts to aid Ellis, his successors, assigns or other legal representatives to obtain and enforce patent protection in said invention in all countries, without further compensation, but at the expense of Ellis, his successors, assigns or other legal representatives.

And Queen's hereby authorizes and requests the Commissioner of Patents or the Comptroller (as the case may be) to issue any and all Letters Patent for said invention or resulting from said application, or from any division, reissue or extension thereof, to Ellis as Queen's sole assignee.


