ASSIGNMENT

WHEREAS I,

Antonius Johannes Josephus Horsten, residing at Muurbloemweg 77, 2555 NC The Hague, The Netherlands (the "Inventor"), am the sole Designer of a design for a ***Window blind hardware profiles*** for which design an International design application with serial number DM/00 4641 was filed in the WIPO office on 5 August 1999, and for which design applications were subsequently filed in other countries with the title "***Roller blind head rail base***",

FURTHER I hereby authorize and request any official of any state, responsible for issuing design or other evidence or forms of any industrial property protection, to issue the same for the invention to the Company, its successors, legal representatives and assigns, in accordance with this assignment.

ALSO I hereby agree that I have the full right to convey my entire, right, title and interest in and to the invention world-wide and all applications for industrial property protection for the invention world-wide and that I have not executed, and will not execute, any agreement in conflict with this assignment.




