INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of January 23, 2001 (as amended, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), is made by each of the signatories hereto (collectively, the "Grantors") in favor of HSBC Bank USA, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Security Agreement referred to below).

WHEREAS, French Fragrances, Inc., a Florida corporation, FD Management, Inc., a Delaware corporation, DF Enterprises, Inc., a Delaware corporation, FFI International, a Delaware corporation, and FFI GmbH, a limited liability company organized under the laws of Switzerland, have entered into an Indenture, dated as of January 23, 2001 (as amended, supplemented, replaced or otherwise modified from time to time, the "Indenture"), with HSBC Bank USA, as trustee (the "Trustee").

WHEREAS, it is a condition precedent to the obligation of the Holders (as defined in the Indenture) to purchase the Notes and the Trustee to enter into the Indenture that the Grantors shall have executed and delivered that certain Security Agreement, dated as of January 23, 2001, in favor of the Collateral Agent (as amended, supplemented, replaced or otherwise modified from time to time, the "Security Agreement"). Capitalized terms used and not otherwise defined herein have the meanings given such terms in the Security Agreement.

WHEREAS, under the terms of the Security Agreement, the Grantors have granted a security interest in certain Property, including, without limitation, certain Intellectual Property of the Grantors to the Collateral Agent for the ratable benefit of the Secured Parties, and have agreed as a condition thereof to execute this Intellectual Property Security Agreement for recording with the United States Patent and Trademark Office, the United States Copyright Office, and other applicable Governmental Authorities in respect of the Intellectual Property (as defined in Section 1(a) hereof).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors agree as follows:

SECTION 1. Grant of Security. Each Grantor hereby grants to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of such Grantor's right, title and interest in and to the Intellectual Property as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such Grantor's Obligations. The following definitions are applicable to this grant of security:

(a) "Intellectual Property": the collective reference to (i) the Copyrights, Copyright Licenses, Patents, Patent Licenses, Trademarks, Trademark Licenses, Trade Secrets and Trade Secret Licenses listed on Schedule 1, (ii) all other rights, priorities and

privileges relating to intellectual property, including, without limitation, any other Copyrights, Copyright Licenses, Patents, Patent Licenses, Trademarks, Trademark Licenses, Trade Secrets and Trade Secret Licenses, and (iii) all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom; provided, however, that Intellectual Property shall exclude (A) intangible assets related to such Copyrights, Copyright Licenses, Patents, Patent Licenses, Trademarks, Trademark Licenses, Trade Secrets and Trade Secret Licenses owned by third parties and (B) any intangible assets related to such Copyrights, Copyright Licenses, Patents, Patent Licenses, Trademarks, Trademark Licenses, Trade Secrets and Trade Secret Licenses associated with Elizabeth Taylor fragrances and cosmetics and (C) products of the Company and/or its Subsidiaries sold in Columbia under the "Elizabeth Arden," "Arden for Men" and "Body Clear" brand names, in each case with respect to deodorant and antiperspirant products; provided, further, that, with respect to clauses (i) and (ii) above only, such rights, priorities and privileges shall be deemed to be Intellectual Property hereunder only,

- (A) to the extent acquired in the Arden Acquisition,
- (B) to the extent a perfected lien (or its equivalent) may be created therein,
- (C) to the extent products related to such Intellectual Property are manufactured by any Grantor (or its predecessor) at the time the Notes are issued, and
- (D) to the extent registered, registrable, used or useful in:
 - (1) the United States;
 - (2) member states of the European Union;
 - (3) Argentina, Australia, Brazil, Canada, Indonesia, Japan, Korea, Mexico, New Zealand, Puerto Rico, Saudi Arabia, Singapore, South Africa, Switzerland and Taiwan; or
 - (4) in any other jurisdiction in which the Company or any Subsidiary of the Company avails itself of such jurisdiction's laws to register, file, preserve or otherwise protect or evidence its interest in such Intellectual Property within 90 days of the Arden Acquisition.

(b) "Trademarks": (i) all trademarks, service marks, trade names, corporate names, company names, business names, trade dress, trade styles, logos, or other indicia of origin or source identification, trademark and service mark registrations, and

applications for trademark or service mark registrations and any new renewals thereof, in all forms and formatives, including composites, and any use or mark that includes any of the foregoing or any use or mark that is confusingly similar to, or likely to be confused with, any of the foregoing, including, without limitation, each registration and application identified in Schedule 1, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above;

(c) **“Patents”**: (i) all patents, patent applications and patentable inventions, including, without limitation, each patent and patent application identified in Schedule 1, (ii) all inventions and improvements described and claimed therein, (iii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iv) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (v) all reissues, divisions, continuations, continuations-in-part, substitutes, renewals, and extensions thereof, all improvements thereon and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(d) **“Copyrights”**: (i) all copyrights, whether or not the underlying works of authorship have been published, and all works of authorship and other intellectual property rights therein, all copyrights of works based on, incorporated in, derived from or relating to works covered by such copyrights, all right, title and interest to make and exploit all derivative works based on or adopted from works covered by such copyrights, and all copyright registrations and copyright applications, and any renewals or extensions thereof, including, without limitation, each registration and application identified in Schedule 1, (ii) the rights to print, publish and distribute any of the foregoing, (iv) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iv) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (v) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(d) **“Trade Secrets”**: (i) all trade secrets and all confidential and proprietary information, including know-how, customer lists, manufacturing and production processes and techniques, inventions, research and development information, technical data, financial, marketing and business data, pricing and cost information, business and marketing plans, and customer and supplier lists and information acquired in the Arden

Acquisition, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; and

(e) "Licenses": (i) all licenses or agreements, whether written or oral, providing for the grant by any Grantor of: (A) any right to use any Trademark or Trade Secret, (B) any right to manufacture, use or sell any invention covered in whole or in part by a Patent, and (C) any right under any Copyright including, without limitation, the grant of rights to manufacture, distribute, exploit and sell materials derived from any Copyright including, without limitation, any of the foregoing identified in Schedule 1, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations of any of the foregoing, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto.

SECTION 2. Recordation. Each Grantor authorizes and requests that the Register of Copyrights, the Commissioner of Patents and Trademarks and any other applicable government officer record this Intellectual Property Security Agreement.

SECTION 3. Execution in Counterparts. This Agreement may be executed in any number of counterparts (including by telecopy), each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. This Intellectual Property Security Agreement shall become effective as of the date first above written and be binding upon a Grantor when a counterpart hereof executed on behalf of such Grantor shall have been received by the Collateral Agent.

SECTION 4. Governing Law. This Intellectual Property Security Agreement shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.

SECTION 5. Conflict Provision. This Intellectual Property Security Agreement has been entered into in conjunction with the provisions of the Security Agreement and the Indenture. The rights and remedies of each party hereto with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement and the Indenture, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Intellectual

Property Security Agreement are in conflict with the Security Agreement or the Indenture, the provisions of the Security Agreement or the Indenture shall govern.

SECTION 6. Continuing Security Interest. This Agreement shall create a continuing security interest in the Collateral and shall:

- (a) remain in full force and effect until the satisfaction of all obligations of the Grantors under the Indenture, the Security Documents and the Notes;
- (b) be binding upon the Grantors, their successors, transferees and assigns; and
- (c) inure, together with the rights and remedies of the Collateral Agent hereunder, to the benefit of the Collateral Agent, the Trustee and the Holders.

PATENT LEATHER - We filed some applications for the trade mark PATENT LEATHER and contacted Cussons to ask for consent. (They own registrations for LEATHER and IMPERIAL LEATHER). Cussons refused consent and Elizabeth Arden lost interest in the name PATENT LEATHER. It was therefore agreed that we would withdraw any applications for PATENT LEATHER. Unfortunately, some of the applications have not been withdrawn and are either still pending or have proceeded to registration. The applications should be withdrawn or the registrations cancelled.

Wet Seal would also agree to use the ARDEN B. mark in a stylized script only, or in another logotype that is not confusingly similar to the ELIZABETH ARDEN mark. Finally, Wet Seal would avoid use of the color red in a manner likely to cause confusion with Elizabeth Arden's RED DOOR salons, and would not use the name ELIZABETH or variations thereof in its advertising or as the name of any spokesperson.

Unopco Sub. Inc. and Conopco Inc. dba Elizabeth Arden Co. v.
Grandiflorum Perfumes Ltd. (TTAB)

Elizabeth Arden filed an Opposition proceeding in September, 1999 in the U.S. based on its use of the mark Millenium against the mark MILLENIUM FRAGRANCES in class 3 for perfume, toilet water, perfumed skin lotion, bath gels, bath soaps, and essential oils for personal use. Grandiflorum defaulted in a similar opposition proceeding brought by Avon, and therefore the application has been rejected and the Arden opposition is mute.

Unopco Sub, Inc. and Conopco, Inc. dba Elizabeth Arden Co.
v. Westridge Laboratories Inc., Opposition No. 117,541(TTAB)

Elizabeth Arden filed an Opposition proceeding in March, 2000 in the U.S. based on its use of the mark MILLENIUM against the mark MILLENIUM in class 5 for gels and liquids for use as personal lubricant. The parties are in settlement discussions.

Unopco Sub, Inc. and Conopco, Inc. dba Elisabeth Ardent Co.
v. Blasser Brothers Inc., Opposition No. 119,635 (TTAB)

Elizabeth Arden filed an Opposition proceeding in July, 2000 in the U. S. based on its use of the mark MILLENIUM against the mark COLLECTION 2000 MILLENIUM in class 3 for perfume, lipstick, blushes, eye pencils, hair shampoo, hair conditioner, skin moisturizing creams, face creams, hand creams, and eau de toilette. Avon, which has also filed an opposition, is engaged in settlement discussions with Blasser Brothers.

Unopco Sub, Inc, and Conopco Inc. dba Elizabeth Arden Co. v.
Andin International, Inc., (TTAB)

Elizabeth Arden filed an Opposition proceeding in August, 2000 in the U.S. based on its use of the mark MILLENIUM against the mark THE MILLENIUM HEART and Design in class 3 for body cream, skin cream, essential oils for personal use body scrubs, facial cleansers, perfumes, eau de toilette, perfumed hair lotion, perfumed bath and shower gels. The parties are in settlement discussions.

Unopco Sub, Inc. and Conopco Inc. dba Elizabeth Arden Co. v.
Looking Glass Partners. LLC

Elizabeth Arden considered taking action against Looking Glass to prevent its U.S. trademark application for the MILLENIUM BUG in class 3 from proceeding to registration. However, Avon has already filed an opposition against this mark. Looking Glass has defaulted and its application refused. Accordingly, opposition is not necessary.

Unopco Sub, Inc. and Conopco, Inc. dba Elizabeth Arden Co.
v. The Red Door Salon

Elizabeth Arden sent a cease and desist letter in late July, 2000 to Denise Greathouse, owner of The Red Door Salon and The Red Door II Salon in Columbus, Ohio. Arden has demanded that Greathouse immediately cease use of the RED DOOR name. The parties have entered into a settlement

agreement whereby Ms. Greathouse agreed to cease use of the RED DOOR mark.

Avon Products, Inc. and Conopco, Inc. dba Elizabeth Arden Co. v. Charlotte D Sharp-Pfeifer, (TTAB)

Avon and Elizabeth Arden have filed an Opposition proceeding in September, 2000 in the U.S. based on Avon's use of the mark MILLENNIA and Arden's use of the mark MILLENIUM against the mark MILLENIUM MAN in class 3 for perfumes and colognes. The parties are in settlement discussions.

Unopco Sub, Inc. and Conopco, Inc. dba Elizabeth Arden Co. v. Clairol Incorporated, (TTAB)

Elizabeth Arden has filed an Extension of Time to Oppose the mark NATURAL VOLUME in class 3 for hair care products based on its use of NATURAL VOLUME for mascara. The parties are in settlement discussions.

Unopco Sub, Inc. and Conopco, Inc. dba Elizabeth Arden Co. v. Bacara Spa

Elizabeth Arden has sent a cease and desist letter to Bacara Spa in California, which has used a photograph in its advertising which Arden believes is a copyright infringement of a photograph of Elizabeth Taylor licensed from Herb Ritts for use in connection with Elizabeth Taylor White Diamonds fragrance. Arden is demanding that Bacara immediately cease use of its photograph. No substantive response has been received. A follow-up letter has been sent to January 11, 2001 reflecting the fact that it appears the photo is no longer being used.

5. MILLENIUM - We have filed opposition to trade mark application No 822034778 MILENIO 20 20. We instructed the opposition on 9 October 2000.

6. ELIZABETH ARDEN 5TH AVENUE - We have opposed an application for GRANDE AVENUE in the name of Société Parisienne de Parfums et Cosmétiques S.A.

1. ELIZABETH ARDEN - Opposition to ELIZABETH ARDEN (in Chinese Characters) No 716554 in Class 18 in the name of Hainan Yili Leather Co Ltd.

2. SUNFLOWERS - Possible Opposition to SUNFLOWERS (word in Chinese) in the name of Bali Beilisi Xiangshui Limited. We need to confirm whether an opposition was filed.

4. ELIZABETH ARDEN - Conflict with Argentina Web Design. This company is related to another company with whom we have had internet disputes. We are watching the activities to see whether the name elizabeth-arden.net falls free for reservation again.
5. ELIZABETH ARDEN - Conflict with Parma. We are checking the activities of this company under the web site address elizabeth-arden.com.

Italy

1. MILLENIUM - We have opposed an application for III MILLENIUM in the name of Di Cesare Sergio. Opposition was instructed on 1 September 2000.
