WHEREAS, Alok Sharma, a citizen of Canada whose address is Suite 519, 105 - 150 Crowfoot Cres., N.W., Calgary, Alberta T3G 3T2, Canada (hereinafter called ASSIGNOR) has invented certain new and useful improvements in a SPARKLER for which application for Letters Patent of the United States has been made; and
