TANDEM MASS SPECTROMETER COMPRISING ONLY TWO QUADRUPOLE FILTERS
which application was executed by ME on the date(s) indicated below, and

Whereas Bruker Daltonik GmbH, a German corporation having a place of business at Fahrenheitstrasse 4, 28359 Bremen, GERMANY, which, together with its successors and assigns, is hereinafter called "Assignee," is desirous of acquiring the title, rights, benefits and privileges hereinafter recited;

Now, therefore, for valuable consideration furnished by Assignee to ME, receipt and sufficiency of which is hereby acknowledged, ME do hereby, without reservation:

1. 4. 5.
