protection for said invention and to claim the aforesaid benefits of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it. ASSIGNOR does hereby agree to execute all instruments and documents required for the making and prosecution of applications for United States and foreign letters patent on said invention, including any instruments and documents needed for vesting title thereto in said ASSIGNEE, its successors and assigns, for litigation regarding said letters patent, or for the purpose of protecting title to said invention or letters patent therefor.
