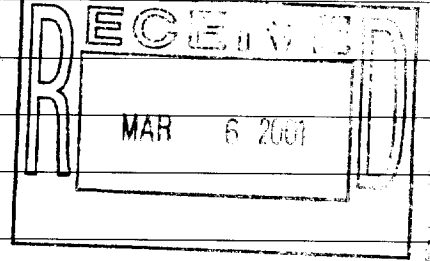

## ASSIGNMENT
