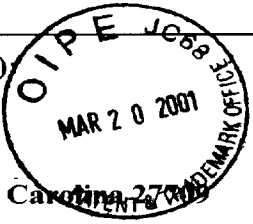

ASSIGNMENT

WHEREAS, in an Assignment dated March 13, 1992, and having an Apostille dated March 17, 1992, Pavel Novotny confirmed ownership of U.S. Patent Application Serial No. 773,649, filed October 17, 1991, and the invention therein, by THE WELLCOME FOUNDATION LIMITED, a company then incorporated in England whose registered office was Unicorn House, 160 Euston Road, London, NW1 2BP, England. In the same Assignment, THE WELLCOME FOUNDATION LIMITED in turn assigned and transferred its whole right, title, and interest in and throughout the United States of America, its territories and possessions, in and to U.S. Serial No. 773,649, and the invention therein and in and to any priority rights in respect of U.S. Serial No. 773,649 and in and to any renewals thereof, and in and to any and all Letters Patent of the United States of America which may be granted on the invention described in U.S. Serial No. 773,649 and in and to any and all reissues thereof including any priority rights under the International Convention for the United States of America to BURROUGHS WELLCOME CO., a corporation then organized and existing under and by virtue of the laws of the State of North Carolina and having its principal place of business at Research Triangle Park, North Carolina.

WHEREAS, in a Deed of Assignment dated April 10, 1992, THE WELLCOME FOUNDATION LIMITED agreed to procure the assignment by BURROUGHS WELLCOME CO., WELLCOME FOUNDATION LIMITED's U.S. subsidiary, of U.S. Patent Application Serial No. 773,649, filed October 17, 1991, to EVANS MEDICAL LIMITED then having an address of Langhurst, Horsham, West Sussex, RH12 4QD, England.

WHEREAS, GLAXO WELLCOME INC., a corporation organized and existing under the laws of North Carolina, and having a business address at Five Moore Drive, Research Triangle Park, North Carolina, 27709, is the successor in interest to BURROUGHS WELLCOME CO. This change in the name of the corporation from BURROUGHS WELLCOME CO. to GLAXO WELLCOME INC. was set forth in the Articles of Amendment of the Articles of Incorporation of Burroughs Wellcome Co., which document was recorded with the Secretary of the State of North Carolina on October 30, 1995.


WHEREAS, MEDEVA PHARMA LIMITED, having a business address at Medeva House, Regent Park, Kingston Road, Leatherhead, Surrey, KT22 7PQ, England, is the successor in interest to EVANS MEDICAL LIMITED. This change in the name of the company from EVANS MEDICAL LIMITED to MEDEVA PHARMA LIMITED was set forth in the Certificate of Incorporation on Change of Name, which document was recorded with the Registrar of Companies for England and Wales, Company House, London, on July 6, 1998.

NOW, THEREFORE, in accordance with the April 10, 1992 Deed of Assignment, GLAXO WELLCOME INC., the successor in interest to BURROUGHS WELLCOME CO., sells, assigns and transfers, its entire right, title, and interest in and to United States Patent Application Serial No. 08/450,336, filed May 25, 1995, to MEDEVA PHARMA LIMITED of Medeva House, Regent Park, Kingston Road, Leatherhead, Surrey, KT22 7PQ, England, the successor in interest to EVANS MEDICAL LIMITED. United States Patent Application Serial No. 08/450,336 claims priority from the following applications: U.S. Serial No. 08/221,451, filed April 1, 1994, U.S. Serial No. 08/137,778, filed October 19, 1993, and U.S. Serial No. 07/773,649, filed October 17, 1991.


