ASSIGNMENT

WHEREAS, Masaaki FUKUMOTO, Shoichiro ISHIGAKI, Toshiaki SUGIMURA and Hirotaka NAKANO, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled, Wireless Telecommunications Unit Attachable to and Detachable from an External Unit, executed by Assignors on the same date as this Assignment;

any such patent application or patent; and that the Assignors will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
