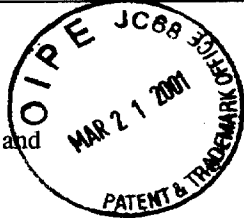

ASSIGNMENT

(JOINT)

THIS ASSIGNMENT, by LARS Å HANSON, LARS BALTZER, INGER MATTSBY-BALTZER and GUNNAR T. DOLPHIN each residing at Göteborg, Sweden, (hereinafter referred to as "the Assignors"), respectively, witnesseth:

WHEREAS, the Assignors have invented certain new and useful improvements in PEPTIDES BASED ON THE SEQUENCE OF HUMAN LACTOFERRIN AND THEIR USE set forth in an application for Letters Patent of the United States,



