ASSIGNMENT

WHEREAS, WE, David Allison Bennett, 20710 14th Drive, SE, Bothell, Washington 98012; Paul Bilibin, 1716 - 216th Street SW, Lynnwood, Washington 98036; Jinyue Liu, 23029 NE 18th Street, Redmond, Washington 98053; and Charles D. Mentzer, 4307 - 210th Place NE, Redmond, Washington 98053, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled APPARATUS, SYSTEMS AND METHODS FOR APPLYING BILLING OPTIONS FOR MULTIPLE CARRIERS FOR ONLINE, MULTI-CARRIER, MULTI-SERVICE PARCEL SHIPPING MANAGEMENT, application serial number 09/684,865, filed October 6, 2000;




