WHEREAS, I, ^{19462 PA}Paul Joseph Andersen, of 355 Brighton Road, Plymouth Meeting, Pennsylvania ~~19401~~ (hereinafter referred to as "ASSIGNOR"), have made an invention entitled EXHAUST GAS CATALYST COMPRISING RHODIUM, ZIRCONIA AND RARE EARTH OXIDE, for which an application for United States Letters Patent was filed on December 21, 2000, under Application No. 09/720,151;
