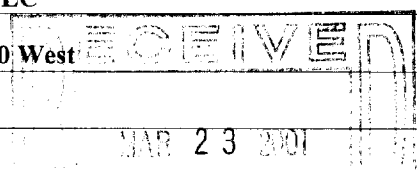



AND WE HEREBY authorize and request any official of any State whose duty consists of issuing patents, or other evidence or forms of any industrial property protection on any aforesaid application, to issue same to said ASSIGNEE, its successors and assigns, in accordance herewith;

AND WE HEREBY covenant and agree with said ASSIGNEE, its successors and assigns, that we have the full right to convey the entire interest assigned herein, and that we have not executed, and will not execute, any agreement in conflict herewith, and that we will not do any other act whatsoever conflicting with these presents, and that we or our successors, assigns, executors, or administrators will at any time upon request, without further or additional consideration but at the expense of the ASSIGNEE, its successors and assigns, communicate to the ASSIGNEE, its successors and assigns, any facts known to ASSIGNOR respecting said inventions, and testify in any legal proceedings, sign any lawful papers, execute any original, divisional, continuation, and continuation-in-part applications, make any rightful oaths, and generally do such additional acts as ASSIGNEE, its successors and assigns, may deem necessary or desirable to obtain and enforce proper protection for said inventions throughout the TERRITORY.

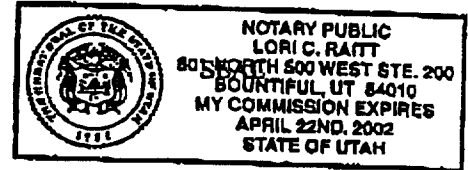
