

Recitals

A. Assignor owns the entire right, title and interest in and to an invention, entitled METHOD AND APPARATUS FOR DYNAMICALLY FORMING CUSTOMIZED WEB PAGES FOR WEB SITES for which an application for United States Letters Patent Application Serial No.: 09/185,145 was filed on November 3, 1998, by an assignment from the inventor(s), which assignment was recorded in the United States Patent and Trademark Office at Reel 010581, Frame 0818, on January 31, 2000.

B.
