PATENT APPLICATION AND INVENTION ASSIGNMENT

In consideration of One Dollar (\$1.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, we, the undersigned, Kevin A. Kelly, of 744 Amity Rd. Hereby sell, assign and transfer to Deca-Medics, Inc., a corporation of Ohio, having a place of business at 4101 Leap Road, Hilliard, Ohio 43026, its successors, assigns and legal representatives, the entire right, title and interest (excepting the reversionary interest discussed below) for the United States and all foreign countries, in and to any and all improvements which are disclosed in the application for United States Letters Patent, which is executed concurrently herewith and is entitled CHEST COMPRESSION APPARATUS FOR CARDIAC ARREST (DEC 101), and in and to said application including all rights of priority arising therefrom and in and to all divisional, continuing, substitute, renewal, reissue, and all other applications for Letters Patent which have been or shall be filed in the United States and all foreign countries on any of said improvements; and in and to all original and reissued patents which have been or shall be issued in the United States and all foreign countries on said improvements; provided that the undersigned inventors retain a reversionary interest under which the right, title and interest sold, assigned and transferred hereby reverts to the undersigned inventors automatically and without the need for further documentation upon the bankruptcy or the filing of papers seeking the protection of bankruptcy of the Assignee or its successors in interest while the same holds the right, title and interest transferred hereby, the insolvency or ceasing of business operations of the Assignee or its successors in interest while the same holds the right, title and interest transferred hereby, or an equivalent of bankruptcy, filing of bankruptcy papers, insolvency or ceasing of business operations;



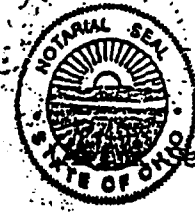
