ASSIGNMENT

WHEREAS, I, Thierry Richard, residing at 8 Rue Des Clos, 78770 Viluers, Le Mahieu, France, has invented certain new and useful improvements in "Surgical Staple Inserter" for which US Patent No. 5,346,115 issued September 13, 1994 and sole holds the right, title and interest to this US Patent.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to Edrich Vascular Devices, Inc., its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid, Edrich Vascular Devices, Inc., its successors, legal representatives and assigns to obtain and enforce proper patent protection for said improvements in all countries.
