WHEREAS, we are the joint inventors of a new and original design for a **BED** for which we are about to make application for Letters Patent of the United States, and for which we have executed a declaration on the day of , 2001.



We hereby request the Assistant Director for Patents to issue the Letters Patent in accordance with this instrument.


