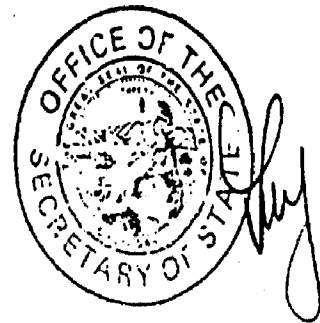

The undersigned certify that:

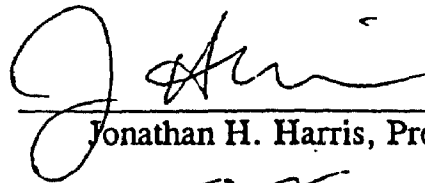
1. They are the president and secretary respectively, of Crystalline Materials Corporation, a California Corporation.
2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:

The name of the Corporation is CMC Wireless Components, Inc.

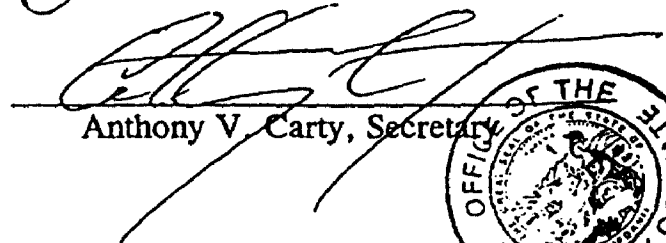
3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors of said Corporation.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporation Code. The total number of outstanding shares of the Corporation is 195,965 shares of Common Stock and 45,284,264 shares of New Series A Preferred Stock. The number of shares of Common Stock, and New Series A Preferred voting in favor of the amendment equaled or exceeded the vote required. The vote required was a majority of the outstanding shares of Common Stock and New Series A Preferred Stock, voting together as a single class as required by the Articles of Incorporation.
