ASSIGNMENT OF PATENT

THIS AGREEMENT entered into on ~~November~~ ^{January 16} ~~_____~~ ²⁰⁰¹ 2000 by and between JAMES SOUDER and JUDITH SOUDER ("SOUDER") on the one hand, and NORFIELDS CORPORATION ("NORFIELDS") on the other hand.

WHEREAS, JUDITH SOUDER is the owner of U. S. Patent No. 5,817,000 ("the patent") issued September 13, 1996, naming JAMES SOUDER as the inventor;

WHEREAS, NORFIELDS is desirous of acquiring ownership of the patent, including the ability to sue infringers of the patent for damages and injunctive relief;

NOW, THEREFORE for good and valuable consideration, the receipt and sufficiency of which is expressly acknowledged,

SOUDER represents and warrants that the above recitals are true and correct, and are hereby incorporated by reference.


SOUDER hereby assigns, transfers and sets over unto NORFIELDS, and its successors and assigns, 50% of their right, title and interest to the patent, including the right to sue infringers for damages as well as injunctive relief.

The corporate party to this Agreement represents, warrants and covenants (a) that it is a corporation duly organized, validly existing and in good standing under the laws of the state of its incorporation and has the corporate powers to own its patented assets and intellectual properties and to carry on its business as now being and heretofore conducted; (b) the execution, delivery and performance of the Agreement have been duly authorized, do not violate its certificate of incorporation by-laws or similar governing instruments or applicable law and do not, and with the passage of time will not, materially conflict with or constitute a breach under any other agreement,

judgment or instrument to which it is a party or by which it is bound; and (c) this Agreement is a legal, valid and binding obligation of such party, enforceable in accordance with its terms.


