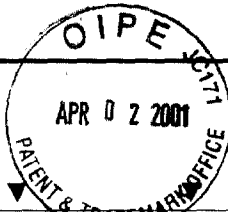

ASSIGNMENT BEFORE PATENT




