

2. FURTHER ASSURANCE

The provisions of Clause 20.2 of the Technology Transfer Agreement between Dalgety Plc and the Assignee dated 25th January, 1998 shall apply to this Assignment without prejudice to the other terms of such Technology Transfer Agreement.

3. GOVERNING LAW

This Assignment shall be governed by and construed in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the English Courts in relation to all matters arising out of this Assignment.
