

AND, I, the said ASSIGNOR, for the considerations aforesaid, do hereby covenant and agree to and with the said ASSIGNEE, its successors and assigns, that I, my executors and administrators shall and will do all lawful acts and things, and make, execute, and deliver any and all papers, affidavits, assignments, and other documents, in the United States and all foreign countries, which, in the opinion of counsel for said ASSIGNEE, its successors and assigns, may be required or necessary more effectively to secure to and vest in said ASSIGNEE, its successors, or assigns, the whole right, title, and interest, in the United States and all foreign countries, in and to said improvements and invention, application, Letters Patent,
