The undersigned hereby authorize and request the U.S. Commissioner of Patents and Trademarks and all equivalent foreign officials to issue any and all Letters Patents resulting from said divisions, continuing applications or foreign equivalents to said Assignee, as Assignee of the entire interest, and hereby covenant that they have not executed, and will not execute, any agreements in conflict herewith.
