## ASSIGNMENT



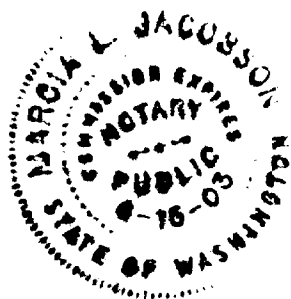
