ASSIGNMENT

WHEREAS, I, WILLIAM H. EBY, a citizen of the United States, residing at 2131 270th Street, Adel, Dallas County, Iowa 50003, am the inventor of an invention in "SOYBEAN CULTIVAR 51367771" for which I have executed an application for Letters Patent of the United States, of even date herewith; and
