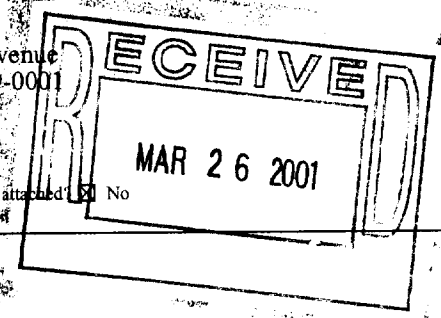

WHEREAS, we, PAUL MARCELO CEREGHINI and SCOTT WOODROOFE CUNNINGHAM, residing at 3147 Olive Knoll Place, Escondido, California 92027 and 151 Calderon Avenue, Apt. 3, Mountain View, California 94041, respectively, have invented certain new and useful improvements in ARCHITECTURE FOR DISTRIBUTED RELATIONAL DATA MINING SYSTEMS, Docket No. 9141, for which we filed an application for Letters Patent of the United States on December 18, 2000, Application Serial No. 09/739,993; and
