ASSIGNMENT AND AGREEMENT



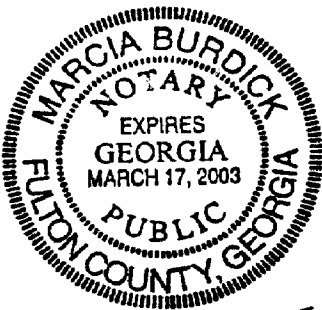
