ASSIGNMENT OF PATENT

WHEREAS, prior to October 1, 2000 (the "Effective Date"), ACCUDART CORPORATION, a New Jersey corporation with a business address of 163 East Union Ave., East Rutherford, New Jersey 07073 ("Assignor") was the sole owner, by assignment, of the entire right, title and interest in and to the patent listed in Appendix A hereto (hereinafter referred to as the APatent) and the inventions claimed and described therein (AIventions); and

WHEREAS, Assignor desires to memorialize such acquisition of the Patent by Assignee as of the Effective Date by entering into this Assignment of Patents *nunc pro tunc*.



Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other governments to issue said Letters Patent to said Assignee as assignee of the entire right, title and interest in and to the same.

Assignor covenants to take all other actions and to execute and deliver all additional instruments and documents, which the Assignee may deem necessary or desirable to make this Assignment fully effective *nunc pro tunc* the Effective Date, and to enable Assignee to enjoy to the fullest extent the rights, title and interests herein conveyed.
