Joint Inventorship

WHEREAS, Klaus KAPFER and Daniel SCHWENDEMANN, hereinafter called the "Assignors", have invented a new and useful INSTALLATION FOR THE TREATMENT AND FURTHER PROCESSING OF THERMOPLASTICS AND METHOD FOR THE OPERATION THEREOF, for a full description of which reference is here made to an application for Letters Patent of the United States executed by them on even date herewith; and
