ASSIGNMENT

WHEREAS, Alexandr I. Bogatov, a citizen of the Russian Federation, residing at ul. Ordzhonikidze, 14-6, Moscow, 117071, Russian Federation, Alexandr E. Drakin, a citizen of the Russian Federation, residing at 4-ya ul. Mariinoi roschi, 17-168, Moscow, 129594, Russian Federation, Yuri V. Kurnyavko, a citizen of the Russian Federation, residing at Golubinskaya ul., 24-1-551, Moscow, 117463, Russian Federation, and I, Vasily I. Shveykin, a citizen of the Russian Federation, residing at App. 11, Bldg. 1, 33, Arhetektora Vlasova St., Moscow, 117393, Russia, have invented certain new and useful improvements in a SEMI-CONDUCTOR OPTICAL AMPLIFIER for which an application for Letters Patent in the Russian Federation (Application No. 98103653, now Patent No. 2134007) has been filed on March 12, 1998, and an application under the Patent Cooperation Treaty (Application No. PCT/RU99/00067) has been filed on March 11, 1999;

AND WHEREAS, I, Vasily I. Shveykin, own all right, title, and interest to this invention outside the Russian Federation, to all patent applications worldwide for this invention which have been filed or may be filed, and to all patents worldwide outside the Russian Federation which have been granted or may be granted, in part or in full;



AND WHEREAS, D-LED Corporation (hereinafter "ASSIGNEE"), a Delaware Corporation, with its principal place of business at 100 S.E. Second Street, 32<sup>nd</sup> Floor, Miami, Florida, 33131, desires to acquire the entire right, title, and interest in and to the said improvements and the said applications:

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, I, Vasily I. Shveykin, hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title, and interest throughout the world in, to and under the said improvements outside the Russian Federation; said application filed under the Patent Cooperation Treaty; all applications that have been or hereafter may be filed in the United States national phase of said application filed under the Patent Cooperation Treaty, and all divisions, renewals and continuations of any of these applications, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof; all rights of priority under International Conventions and all applications for Letters Patent which have been or hereafter may be filed for said improvements in any country or countries foreign to the United States; all applications which have been or hereafter may be filed in any country or countries foreign to the United States in the national phase of said application filed under the Patent Cooperation Treaty; and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof, excluding said application filed in the Russian Federation and all divisions, renewals and continuations thereon, and said patent issued in the Russian Federation and all reissues and extensions thereof. I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant and agree that I will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY sell, assign, transfer, set over and convey to ASSIGNEE all my rights in my power of attorney and revoke any powers of attorney issued by me for Alexander P. Bogatov, Alexander E. Drakin, and Yuri V. Kurnyavko as created by the Power of Attorney document executed on July 20, 2000, and as otherwise created before the date of this ASSIGNMENT.
