THIS ASSIGNMENT OF PATENTS (the "Assignment") is made and entered into this ___th day of December 2000, by GLOBESET, INC., a Delaware corporation ("Assignor"), in favor of Trintech Technologies Limited, a limited liability company organized under the laws of the Republic of Ireland ("Assignee").

WHEREAS, Assignor owns all right, title and interest in and to the United States patents, applications for patents identified and set forth in Exhibit A attached hereto, and the inventions embodied in such patents and patent applications (collectively, the "Patents"), and the good will of the business associated with the Patents; and

WHEREAS, pursuant to a certain Asset Purchase Agreement between the Assignor, Assignee, and Trintech Group PLC a public limited company organized under the laws of the Republic of Ireland, dated as of November 19, 2000 (the "Purchase Agreement"), Assignor agreed to assign to Assignee its entire right, title and interest in and to the Patents; and

WHEREAS, pursuant to the Purchase Agreement, Assignee is a successor to that portion of Assignor's business to which the Patents sought to be registered pertain, such business being ongoing and existing.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and delivers to the Assignee, its successors, assigns and legal representatives, the entire right, title and interest of Assignor in and to the Patents and all divisions, reissues, substitutions, continuations, continuations-in-part, and extensions thereof together with the good will associated therewith.

Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks to record Assignee as the owner, of, and to issue in accordance with this instrument, all of the Patents, divisions, reissues, substitutions, continuations, continuations-in-part and extensions in the name of Assignee.

Assignor also hereby sells and assigns to Assignee its successors, assigns and legal representatives the full and exclusive rights, title and interest to the inventions disclosed in said Patents throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries.

Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in Assignee, its successors, assigns and legal representatives.


