And the undersigned hereby agrees to transfer a like interest, upon request of said Assignee, its successors, assigns and legal representatives, and without further remuneration in and to any and all divisions, continuations, substitutes and applications for patents based upon the above-identified Patents, growing out of or related to the inventions of such Patents; and to testify and execute any papers or take such other action on behalf of or for the said Assignee, its successors, assigns and legal representatives, deemed essential by Assignee to Assignee's full protection and vesting of title in and to the inventions hereby transferred and for maintaining any resulting patents concerning said inventions.

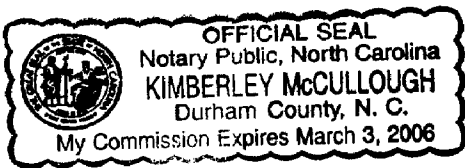
