WHEREAS, we, Edward M. Ifkovits, Joseph F. Zuzick, Jr. and Douglas P. Sprenger have invented certain new and useful improvements in a **METHOD AND DEVICE FOR MOVING CUT SHEETS IN A SHEET ACCUMULATING SYSTEM** identified as File Number **F-129** in the Intellectual Property and Technology Law Department files of the hereinafter-mentioned assignee, and for which an application for United States Patent has been filed on December 29, 2000 under serial number 09/752,364;
