S. Patent No. 6,165,551, in the names of Alexander Lukacs, III et al., and entitled "Protective Compositions and Methods of Making Same", the assignment of which was recorded in the U. S. Patent and Trademark Office on January 12, 1995, at Reel 7290, Frames 678-681, in parent Application Serial No. 08/335,536, which has the same title as above and which was filed on November 7, 1994; and

WHEREAS, KiON Corporation (below referred to as "ASSIGNEE"), a corporation duly organized and existing under the laws of the State of Delaware, United States of America and having its principal office and place of business at 1475 Delashmut Avenue, Columbus, Ohio 43212, is desirous of obtaining the entire right, title and interest in and to the aforesaid invention, and patent application and corresponding patent rights worldwide;

ASSIGNOR agrees to communicate to ASSIGNEE or to its successors, assigns or legal representatives any and all facts known to ASSIGNOR respecting said invention, and with appropriate remuneration to provide testimony in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and reexamination applications, make all rightful oaths and generally do all lawful acts to aid ASSIGNEE or its successors, assigns or legal representatives to obtain and enforce proper patent protection for said invention in all countries and to enhance or perfect ASSIGNEE's title in and to the invention and patent rights therein.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment, except for those licenses referred to in a License Agreement dated February 28, 2001, among Assignor, Assignee and Advanced Materials Lanxide, L.L.C. having an address of 1300 Marrows Road, Newark, Delaware, 19711.
