WHEREAS, Lanxide Technology Company, LP (below referred to as ASSIGNOR), having an address of 1300 Marrows Road, Newark, Delaware 19711, is the assignee of the entire interest in the invention for which application for Letters Patent of the United States was filed on December 16, 1993, in the United States Patent and Trademark Office as Application Serial No. 08/168,902, and issued as U. S. Patent No. 5,489,353, on February 2, 1996, in the name of Clement L. Brungardt and entitled "Process for Forming Ceramic Laminates", the assignment of which was recorded in the U. S. Patent and Trademark Office on December 12, 1994, at Reel 7234, Frames 670-671; and

WHEREAS, KiON Corporation (below referred to as "ASSIGNEE"), a corporation duly organized and existing under the laws of the State of Delaware, United States of America and having its principal office and place of business at 1475 Delashmut Avenue, Columbus, Ohio 43212, is desirous of obtaining the entire right, title and interest in and to the aforesaid invention, and patent application and corresponding patent rights worldwide;

NOW THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR, by these presents does sell, assign and transfer to ASSIGNEE, the entire interest in and to the aforesaid invention, the aforesaid U. S. application and all corresponding foreign patent applications, and all Letters Patent(s) or comparable rights issuing thereon in the United States and in all foreign countries, excluding Japan, together with the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention Relating to patents, Designs and Industrial Models, and any other international agreements to which the United States of America adheres, and the ASSIGNOR hereby authorizes and requests the U. S. Commissioner of Patents and Trademarks and all foreign Patent Offices to issue all Letters Patent(s) or comparable rights issuing on any application as aforesaid to ASSIGNEE, or to its successors, assigns or legal representatives;

ASSIGNOR agrees to communicate to ASSIGNEE or to its successors, assigns or legal representatives any and all facts known to ASSIGNOR respecting said invention, and with appropriate remuneration to provide testimony in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and reexamination applications, make all rightful oaths and generally do all lawful acts to aid ASSIGNEE or its successors, assigns or legal representatives to obtain and enforce proper patent protection for said invention in all countries and to enhance or perfect ASSIGNEE's title in and to the invention and patent rights therein.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment, except for those licenses referred to in a License Agreement dated February 28, 2001, among Assignor, Assignee and Advanced Materials Lanxide, L.L.C. having an address of 1300 Marrows Road, Newark, Delaware, 19711.




