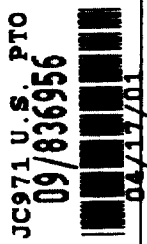

ASSIGNMENT

WHEREAS, I,

Harold E. AND I further grant to The Timken Company, a corporation, its successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.
