## ASSIGNMENT

WHEREAS, Shuzo SEO (inventor), a citizen of Japan, whose post office address is c/o ASAHI KOGAKU KOGYO KABUSHIKI KAISHA, 36-9, Maenochō 2-chōme, Itabashi-ku, Tokyo, Japan (address), hereinafter referred to as the ASSIGNOR, has invented a certain improvement relating to

reissues and prolongations thereof, with all the rights , powers, privileges, and advantages in any ways arising from or pertaining thereto, for and during the term or terms of any and all such Letters Patent when granted, including any and all renewals, reissues, and prolongations thereof, for the use and benefit of said ASSIGNEE and its assigns and legal representatives in as ample and beneficial a manner to all intents and purposes as the said ASSIGNOR might or could have held and enjoyed the same, if this assignment has not been made.

AND said ASSIGNOR hereby agrees to execute all papers necessary to file applications in the United States for said invention and to assign the same to said ASSIGNEE, or any assignee acquiring title to said invention, and to execute any other papers that may be needed in connection with filing said application and securing Letters Patent thereon.

AND said ASSIGNOR authorizes and requests the Commissioner of Patents to issue Letters Patent on said application, and on any and all divisions and continuations thereof, to said ASSIGNEE, its assigns and legal representatives, in accordance herewith.
