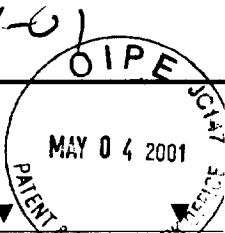

ASSIGNMENT

WHEREAS, David J. Anderson, residing at 1000 Providence Drive, Lawrenceville, Georgia and Senis Busayapongchai, residing at 3736 Sturbridge Court, Tucker, Georgia 30084 (hereinafter "Assignors") have invented certain new and useful improvements in METHOD AND SYSTEM FOR SEARCHING AN INFORMATION RETRIEVAL SYSTEM ACCORDING TO USER-SPECIFIED LOCATION INFORMATION for a full description of which reference is here made to an application for Letters Patent of the United States of America filed in the U.S. Patent and Trademark Office on November 14, 2000 and assigned serial number 09/710,955; and


