Patent Assignment Agreement

This Patent Assignment Agreement is entered into on March 30, 2000, by and between Honeywell International, Inc., and Honeywell Intellectual Property, Inc., each of whom have a place of business at 101 Columbia Road, Morristown, New Jersey 07962 (both of the foregoing Honeywell entities hereinafter "Honeywell"), Phoenix Controls Corporation, having a place of business at 55 Chapel Street, Newton, Massachusetts 02458 ("Phoenix") (Honeywell and Phoenix collectively hereinafter "Honeywell Entities") and MyIndoorAir.com, Inc., a company having a place of business at 55 Chapel Street, Newton, Massachusetts 02458 ("MyIndoorAir").

(1) Honeywell Entities, by a certain Asset Transfer and Product Development Agreement executed on March 30, 2000 ("Asset Agreement") has sold, assigned and otherwise transferred to MyIndoorAir, the entire right, title, and interest in and to the Patents identified on the Schedule attached hereto and made a part hereof, including all claims for infringement thereof, if any, which may have arisen prior to the effective date of the Asset Agreement, all of said rights under such Patents to be held and enjoyed by MyIndoorAir, and that of any successors, assigns or others in privity therewith, to the full end of the term for which the Patents have been or will be granted, extended, reissued or otherwise provided for, as fully and entirely as the same could have been held and enjoyed by Honeywell Entities if the Asset Agreement had not been entered into.

(2) Honeywell Entities further agrees that it will, at the written request of MyIndoorAir, without demanding any further consideration therefore, but subject to reimbursement by MyIndoorAir for reasonable expenses incurred thereby, do all lawful acts including, but not limited to, the execution and acknowledgement of instruments, that are deemed reasonably necessary by MyIndoorAir for obtaining, sustaining, reissuing, and/or enforcing the Patents, and for maintaining, vesting and/or otherwise perfecting MyIndoorAir's right, title and/or interest in and to the Patents.
