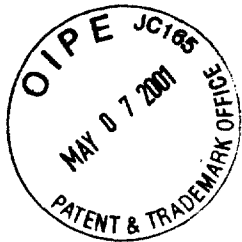



3. On March 20, 1997, the Board of Directors of the Corporation adopted the following resolutions to merge Zenith Data Systems Corporation into the Corporation.


