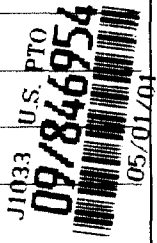

WHEREAS, I, Kenneth M. Kiely, having a residence and post office address at 21 Lyda Drive, Milford, Connecticut 06460, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled ELECTRICAL CABLE CONNECTOR which application was executed by me on the day of the date hereof and is identified by Melvin I. 1. 4. I also agree to provide any reasonable information or assistance to Assignee in any infringement actions Assignee shall decide to initiate in order to enforce the patent rights being transferred herein provided, however, all expenses incurred in such infringement actions shall be paid entirely by Assignee.
