THIS ASSIGNMENT is made the 29th day of January 2001.

BETWEEN

- (1) **THE VICTORIA UNIVERSITY OF MANCHESTER** of Oxford Road, Manchester M13 9PL, United Kingdom (hereinafter called "the Assignor"); and
- (2) **RENOVO LIMITED** a company registered in England with number 3622770 of the Manchester Incubator Building, 48 Grafton Street, Manchester M13 9XX, United Kingdom (hereinafter called "the Assignee").

WHEREAS

- (A) The Assignor is the owner of all rights in and is proprietor of the Patents and Patent Applications short particulars of which are set forth in the Schedule hereto (hereinafter referred to as "the Patents").
- (B) The parties hereto have entered into a Master Technology Agreement dated 18 October 2000 (hereinafter referred to as "the Agreement") whereby the Patents and all rights ancillary thereto are to be transferred by the Assignor to the Assignee on the terms set forth in the Agreement;

NOW THIS ASSIGNMENT WITNESSETH as follows:

1. 2. The Assignor and the Assignee agree to execute any such further supplemental documentation (hereinafter referred to as "the Local Documents") as may reasonably be required by the Assignee in order to register the Assignee as proprietor of the Patents at the respective local Patent Offices around the world.

3. Each of the Local Documents and this Assignment shall be regarded as one and the same instrument and in the event of any conflict between the terms of any of the Local Documents and this Assignment, the terms of this Assignment shall prevail.
4. This Assignment shall be governed by and shall be construed in accordance with English law and the English courts shall have exclusive jurisdiction in relation to any dispute or proceedings arising in relation to this Assignment.
5. **IT IS HEREBY CERTIFIED** that this transaction does not form part of a larger transaction or series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds IR£5,000.

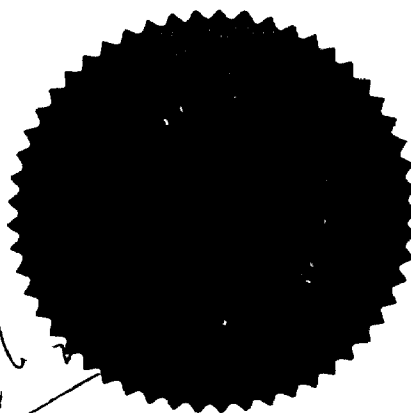
