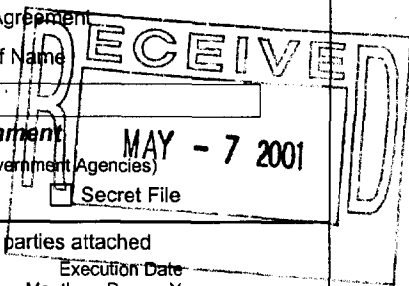

ASSIGNMENT OF PATENT RIGHTS
